ADULT FUNERAL SERVICES

Our full funeral service will include the following:

- Assisting the family with Hospital, GP, Coroner
- Pick up of the deceased from either home or hospital
- Ghusl (washing and shrouding of the deceased)
- Transfer of the deceased after Ghusl to the home or mosque
- Salaatul Janaazah at the cemetery or the mosque
- Burial of the deceased

FUNERAL SERVICES TERMS & CONDITIONS

- In all cases a Funeral Arranger will need to be appointed by the immediate family of the deceased. This individual will act as the sole liaison point with CSMA Birmingham, to ensure funeral services are delivered in line with expectations and to take responsibility for the payment of fees relating to the funeral services provided. Fees relating to funeral services and burial costs provided need to be settled in advance before the burial. An official receipt will be provided.
- The Ghusl will always be supervised by CSMA Birmingham appointed representatives. Attendees must abide
 by instructions given by staff during the conduct of the Ghusl and all have to follow health & safety rules.
 For operational reasons the location where Ghusl is conducted may be varied and the Funeral Arranger will
 be notified of this as much as possible in advance.
- Any damage caused to Ghusl equipment and facilities by not listening to and following instructions as to their use from staff will need be paid for and the liability for this rests with the Funeral Arranger.
- The Rules & Regulations of the cemetery are to be followed by all.
- Any complaints should be in the first instance be made in writing to the CSMA Birmingham.
